8. TFW Certificate (TFW certificate as per sections 6.0, 6.1 and 6.2 of the Information Bulletin.), if applicable.
9. Category certificate if applicable. Reservation of seats will be available for SC/ST/OBC-A/OBC-B/PWD/TFW/EWS category (Respective category certificate as per Sections 5.1, 5.2, 5.3 and 5.4 of the Information Bulletin.). The OBC-A/OBC-B candidates belonging to the Non-Creamy Layer (NCL) are only eligible for consideration as reserved candidates. OBC-A/OBC-B candidates must produce an **updated NCL certificate (on or after 01.04.2024)** during Counselling/ Admission.
10. PWD Certificate (PWD certificate as per section 5.5 of the Information Bulletin), if applicable.
11. Student's Aadhaar Card photocopy.
12. Medical fitness certificate (format is provided on the AGEMC website).


All of the steps like online form submission, document verification, and physical reporting during counselling are essential.
